Payment for trade stands

Each show application must be accompanied by a £25 non returnable deposit dated at time of booking together with a post dated cheque for the remaining balance dated 1 June 2012.

Cancellation

All cancellations must be in writing. Cancellation of a booking, for whatever reason, within 4 weeks of the show date will require payment of 50% of the balance. Cancellations within 2 weeks of the show will require payment of the full balance.

The Organisers shall not be liable to any exhibitor in the event of the show being disrupted due to bad weather, major accident, civil unrest, or any other cause beyond the Organisers' control.

Accessories

Tables, chairs and electricity must be ordered at the time of booking. Please note there will not be any extras available at the show.

Electricity (Internal areas only)

We will, where ordered, supply a single phase supply.

All electrical equipment being used **MUST** be tested to the current regulations. We reserve the right to disconnect any electrical equipment found causing circuitry problems.

Insurance/Health & Safety

Each Exhibitor must be fully compliant with the current trading rules and regulations applicable and relevant to themselves. All traders and exhibitors must be prepared to produce evidence of public liability insurance and risk assessment.
